Free and equal access to public healthcare (5,5 mio. people)
Universal coverage (same system for everyone)
Tax financed (84%) – 4.348 USD pr. capita
Private co-payment in certain areas (16%)

Fully public financed healthcare



Health care (93 %)



Social services and psychiatry (4%)

Regional development (3%)

-Regional growth, business environment policy (SME's), education, tourism, employment, culture, environment, development in rural/remote areas, regional public transport
