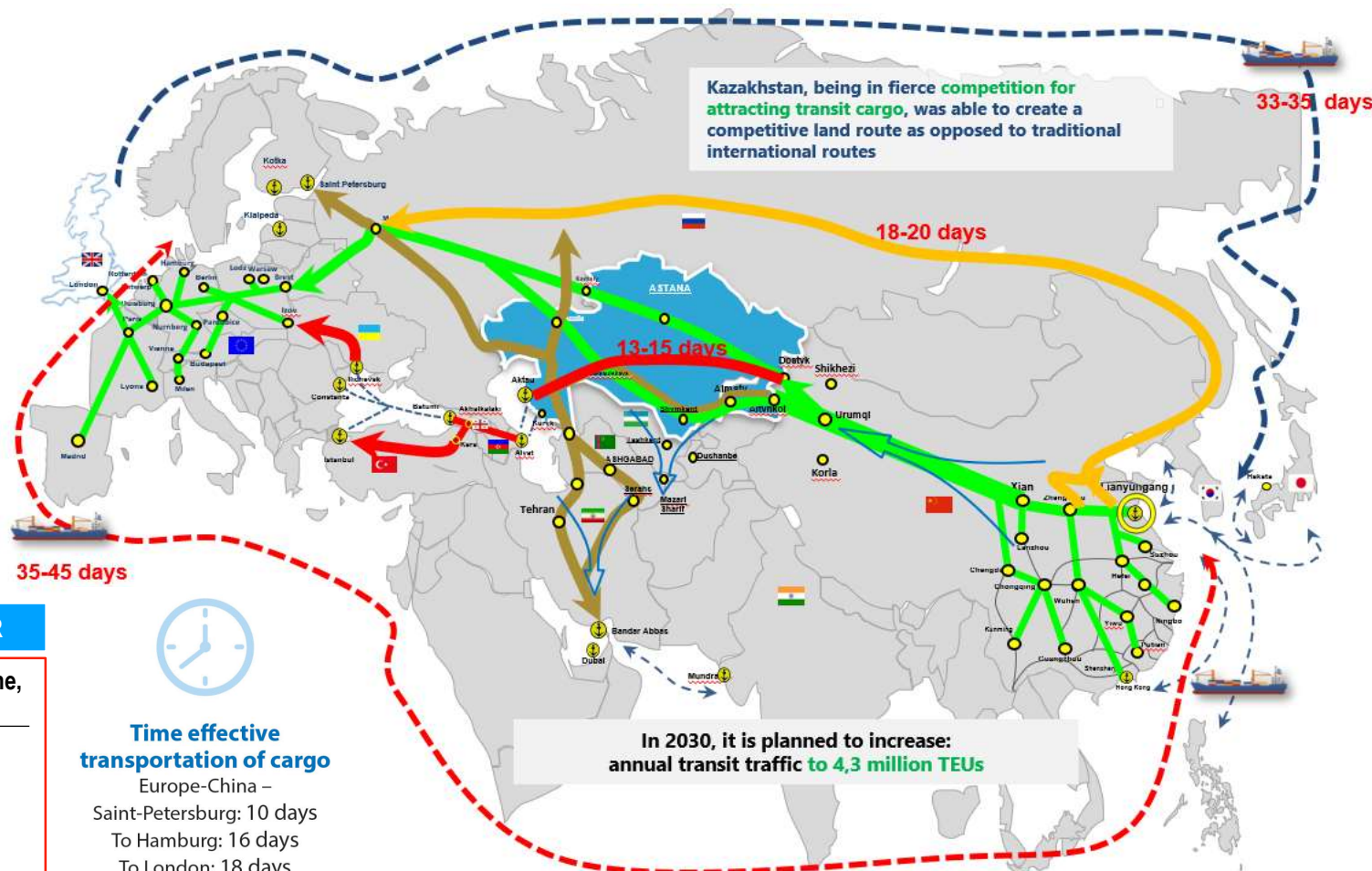

South Sea Route	23 000 ths.	45-60



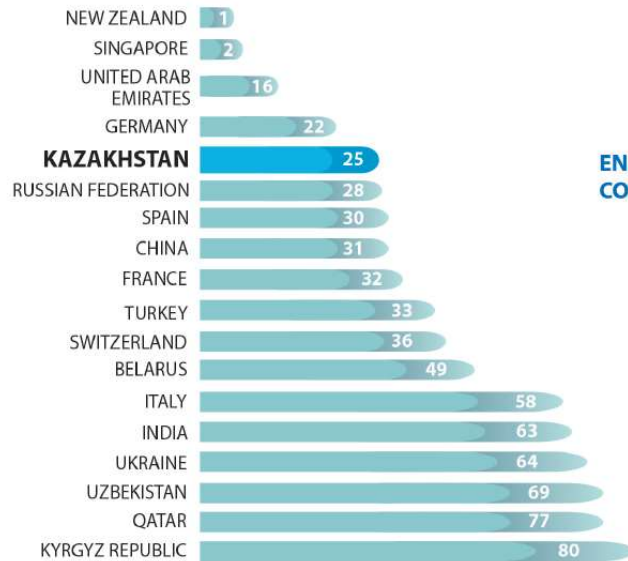

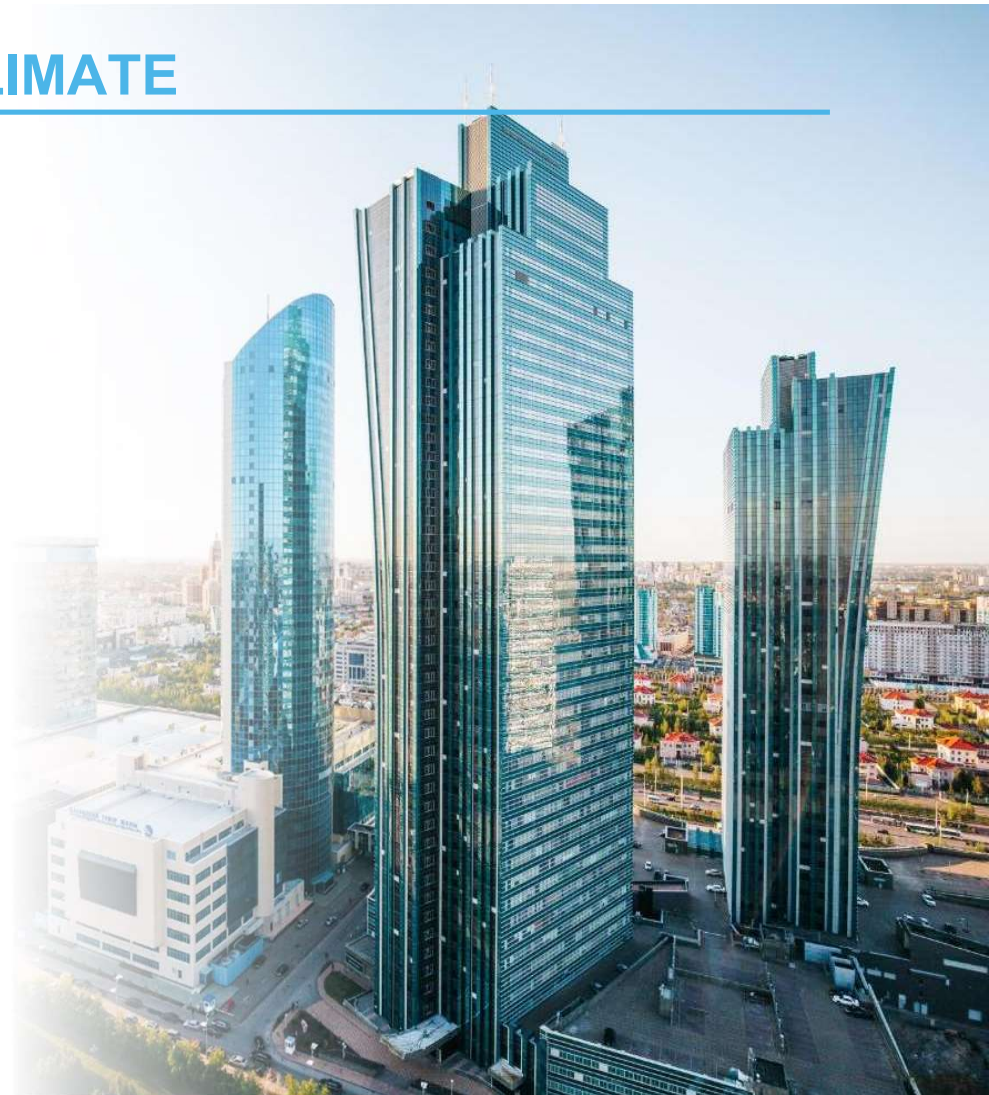

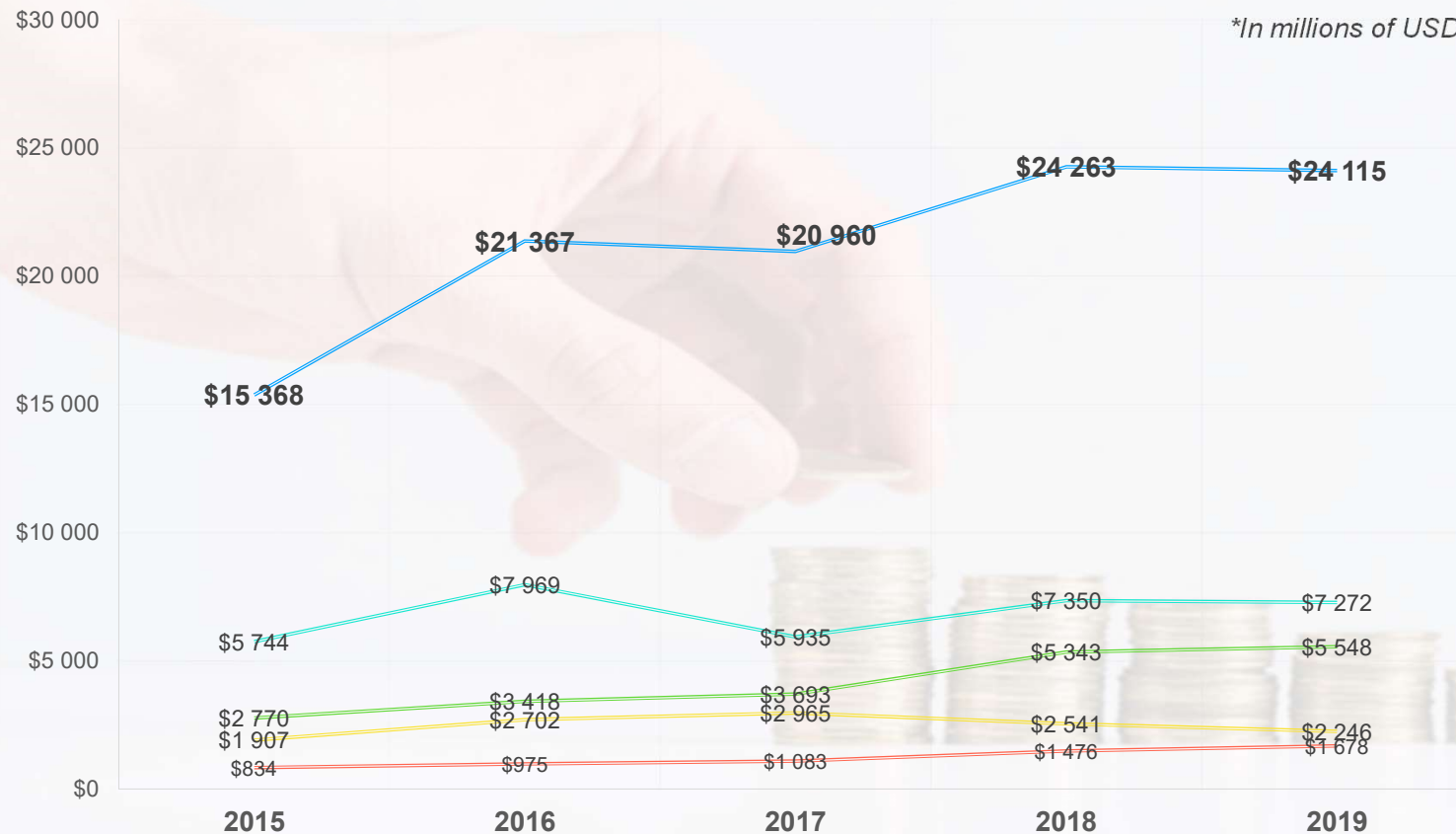
