Target Indicators

- Increasing life expectancy of citizens in 2025 **up to 75 years**
- Reducing the risk of premature mortality from cardiovascular, oncology, chronic respiratory diseases and diabetes (survival probability of 30-year-olds to the age of 70) in 2025 to **15.43%**



Formation of a healthy lifestyle among the population

The people's choice in favor of health

- ↓ Salt intake shall be up to **11 g/day**
- ↓ Prevalence of smoking (aged over 15) shall be **up to 19%**
- ↓ Alcohol consumption (aged over 18) shall be **up to 6.5%**
- ↓ Coverage of citizens engaged in physical culture and sports shall be **up to 36%**
- ↑ Incidence of obesity among children (aged 0-14) shall be **up to 90 per 100 thousand people**
- ↓

Creating a modern public healthcare service

- ↑ Coverage of persons living with HIV with antiretroviral therapy shall be **up to 85%**
- ↓ Road accident deaths shall be **up to 10.15%**
- ↓ Incidence of tuberculosis shall be **up to 43.8 per 100 thousand people**
- ↓ Death rate from unintentional poisoning shall be **up to 2.49 per 100 thousand people**

Comprehensive health support at the PHC level

- ↑ Number of visits to healthcare organizations providing primary health care shall be **up to 4.9 per one resident per year**
- ↓ Adolescent suicide deaths (aged 15-17) shall be **up to 14.8% per 100,000 people**
- ↓ Birth rate among adolescents aged 10-14 shall be **up to 0.021 per 1,000 adolescents of this age**
- ↓ Birth rate among adolescents aged 15-19 shall be **up to 20.6 per 1,000 adolescents of this age**



Improvement of medical care quality

Human capital development

- ↑ The ratio of the average doctor's salary to the average salary in the economy shall be **up to 1.6**
- ↑ The share of extended PHC practice nurses in the total number of nursing staff in the healthcare system of the Republic of Kazakhstan shall be **up to 7%**
- ↑ The number of medical workers for rural population shall be **up to 92.9 per 10,000**
- ↑ The number of clinical trials conducted in the Republic of Kazakhstan per 1 million people shall be **up to 3.5**

Improvement of health care delivery

- ↑ Patient satisfaction with the quality of medical care shall be **up to 65%**
- ↓ Neonatal mortality rate shall be **up to 4.16 per 1,000 newborns**
- ↓ Infant mortality rate among children aged under 5 shall be **up to 10 per 1,000 newborns**
- ↓ The level of primary disability confirmation shall be **up to 28.5 per 10 thousand people**

Creation of a single digital healthcare space

- ↑ The share of medical organizations with implemented healthcare information systems (HIS) that provide the exchange of electronic medical documents with the integration platform shall be **up to 90%**



Sustainable development of the health system

Compulsory Social Health Insurance (CSHI) and promotion of Voluntary

- ↑ Share of total health expenditure from GDP shall be **up to 5%**
- ↑ Share of healthcare expenditures from CSHI shall be **up to 13.6%**
- ↑ Share of private household expenditures in total healthcare expenditures shall be **up to 26.9%**
- ↑ Share of expenditures on outpatient care and healthcare organizations within the guaranteed volume of free medical care and CSHI shall be **up to 60.0%**

Improvement of investment climate in healthcare industry

- ↑ Level of equipment of medical organizations with medical equipment shall be **up to 100%**
- ↓ Depreciation level of buildings of medical organizations shall be **up to 38%**
- ↓ Share of private investment in healthcare shall be **up to 41.3%**

Effective management in Healthcare Service

- ↑ The share of healthcare providers accredited in the area of Social Health Insurance Fund shall be **up to 70%**
- ↓ The percentage of medical organizations that received at least 4 stars in the management rating shall be **up to 45%**

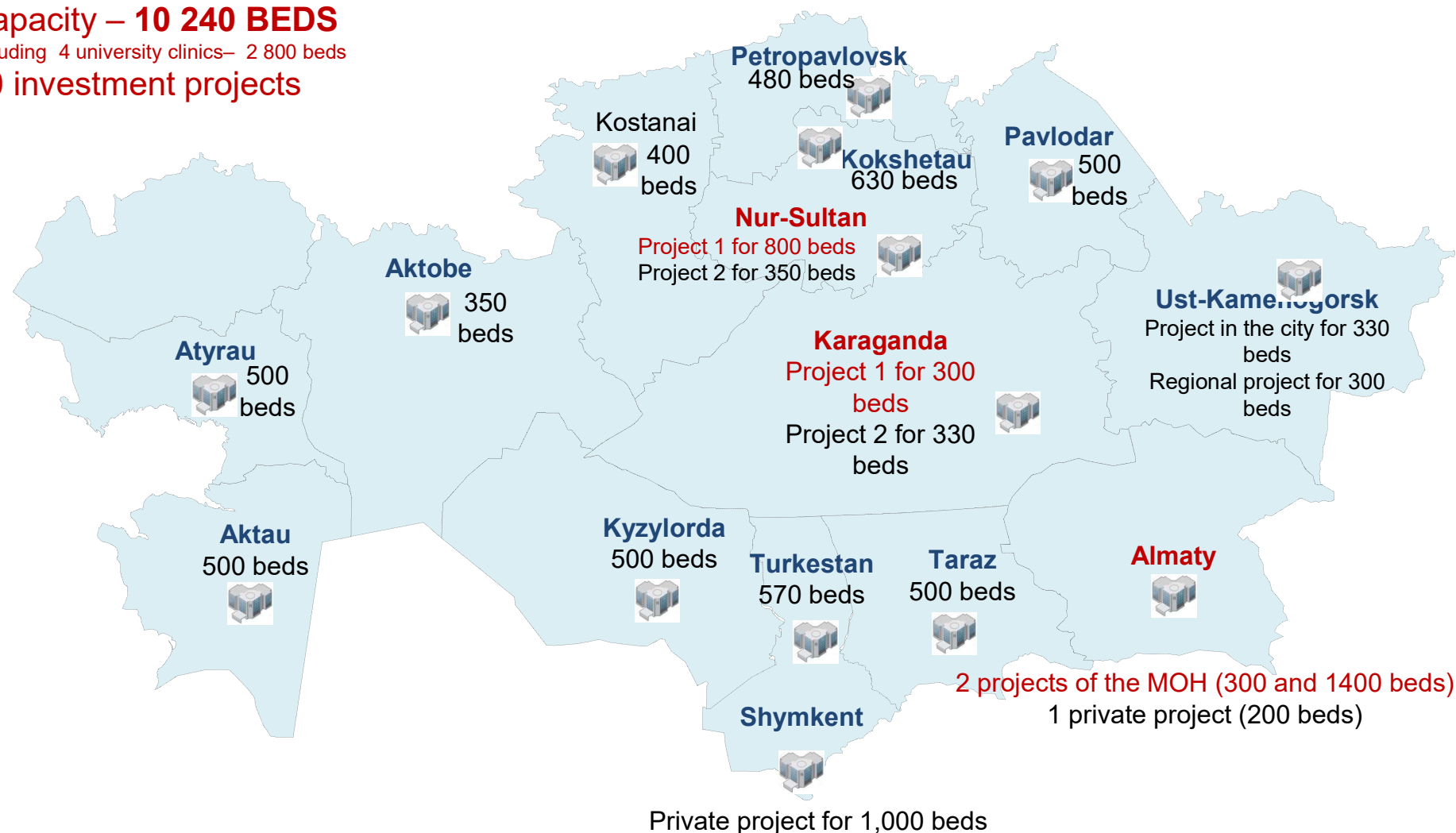
Construction of multidisciplinary hospitals in Kazakhstan

Project objectives

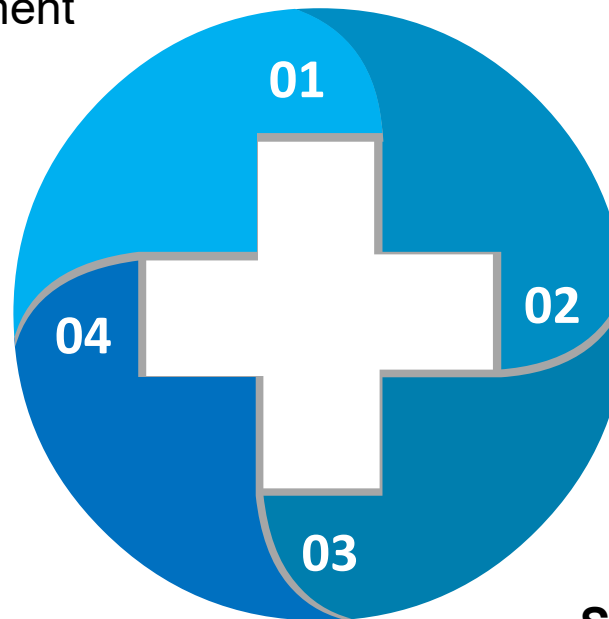
- Creating a base for clinical training of KazNMU students and retraining of doctors
