# **Customised assistance in Brussels**

Sectorial organisation

- Collective actions program (about 100/year)
  - Economic missions, contact days, fairs, meetings with foreign buyers

# Financial incentives for export initiatives

- For which companies?
  - Brussels SMEs according to specific criteria
  - What for?
    - Prospection of new markets outside the EU
    - Participation to tenders outside the EU
    - Participation to international fairs abroad
    - Participation to international fairs outside the EU combined with prospection
    - Collective representation offices outside the EU



- Technical training in Brussels of clients from outside the EU
- Attendance of training courses on foreign trade
- Collaboration with foreign trade consultants
- Development of promotional material (brochures, websites,...)
- How much and how ?
  - Up to 50% of the costs (with upper limits)
  - One electronic form on-line
