- a document for registered activity in order to prove it is registered as a legal entity to pursue the activity related to the subject-matter of the public procurement contract or a proof that it belongs to a relevant professional association in accordance with the regulations of the country where it is registered.

- statement issued by a financial institution or a bank with headquarters in the Republic of Macedonia or by a foreign bank with at least BBB long-term credit rating according to the Moody's Investor Service, Standard and Poor's or Fitch Ratings for the last year, or equivalent to this rating.

- The natural gas distribution systems operated by the economic operator shall be used by at least 40,000 users.

- List of works executed in the last five (5) years in urban areas (see the application forms for participation, annex II.5);

- Excerpt from a list of the number of users served in the last five (5) years or a report by a regulatory body or other institution in the country that performs the distribution of natural gas to a minimum of 40,000 users, which confirms that it served a minimum of 40,000 users within the last five (5) years. The Commission reserves the right to verify the submitted data.

The statements and lists are part of the application form for participation, to be filled in and signed by the economic operator, unless they are issued by a regulatory body or other institution in the country where the natural gas distribution is performed and these documents do not have to be certified by a competent authority.
