The fact that the Bahrain Economic Development Board (EDB) is among our members, creates opportunities for the promotion of investment and business opportunities in Bahrain at DEİK.

As for what did we do in the pandemic process?

There are important investments between the two countries. For example, Investcorp (a private equity fund based in Bahrain) has investments made to Turkish companies in Turkey.

However, we are far from our trade volume target with Bahrain. We should improve our economic relations more. As the Turkish Business World, we should also strive to diversify the investments in Bahrain, especially with the members of BCC & I.

Now, I would like to express some points which may help to develop our bilateral relations with Bahrain:

- First of all, ensuring the visa liberalization between Turkey and Bahrain is very crucial to improve our mutual economic relations. It'll be useful for our Turkish investors who want to invest in Bahrain.
- We should develop our cooperations in these specific sectors:
 - Health tourism, (As Turkey and Bahrain, we're leading countries in the health tourism.)
 - Health, (We're ready to export the products of the mask, respirator and so on in the pandemic process.)
 - E-commerce,
 - Consultancy,
 - Education sector, (We can do networking and case study presentations on that sector together.)

- Technology, (Our technology companies can evaluate Bahrain for that area as well as Dubai)
- Agriculture. (Bahrain can benefit from Turkey's experience in this field.)
- Construction products, (As Turkish business world, we can supply construction products to Bahraini business people)
- Eco-friendly technologies and clean energy,
- Fields such as aluminum, petro-chemistry, iron-steel,
- Cooperation within third countries such as Asia or Africa,
