DEIK-TAIK-ATC 37th Annual Conference 15 April 2019, Washington DC

As the Turkish-American business community, we must ensure the continuation of investment projects, that strengthen 'digital conversion technologies' and highlight the competitiveness of Turkish and American companies within the global arena. In addition, we must work to minimize surtaxes and trade barriers, which are currently impeding our ability to do business together. Indeed, bolstering our economic partnership by enabling free, fair, reciprocal trade, offers major benefits to our economies and workers.
