Now I believe, it is one of the right times about constructing a more diversified, sustainable and fruitful cooperation between our countries to further strengthen the existing relations. Honorable Ministers and Dear Participants,

We were all speaking about Globalization for years. Yes, it was true. Especially during this pandemic time, we're much more speaking about Glocalization. And we're talking more about the concept of "accessibility" rather than the concepts of proximity or distance which are the main parameters of logistics. In the recent unprecedented times, we all realized the significance of market diversity and supply chains.

Turkey and Korea are two countries that have not halted that their production during the pandemic and we would like to increase Turkish companies contribution to the supply chain of Korean companies in the forthcoming period.

I firmly believe that those who are capable of adapting to difficult conditions and those who can manage to keep the supply chain, who can give sufficient confidence to counterparts, will lead the change for a better world and be the winner.

I would like to finish my speech with a Korean saying: **Shijagi banida**, **Starting is the half.**¹ We have also the same proverb in Turkish literature.

I believe that, today we held very important beginning in pandemic times for our economic relations.
