The main part of the Forum

Also in the main part, representatives of state bodies, entrepreneurs from various industries, investors and development partners will perform with presentations.

After the speeches, an exchange of views will take place between the Forum participants and will be organized a B2B meeting.

At the Forum Cooperation agreements, memorandums of understanding and other agreements between entrepreneurs and investors will be signed.

Within the framework of instructions and commissions of the Founder of National Peace and Unity - Leader of the Nation, President of the Republic of Tajikistan, Head of the Government of the country, Emomali Rahmon, according to the implementation of measures to ensure the sustainable development of the country's economy, elevate the welfare of the population, improve the investment climate, and organize events within the announced 2022- 2026 years of industrial development, on August 17, 2022, the international business and investment forum "Pomirinvest-2022" will be held.

The purpose of the Forum

Moderators will be identified and elected by the State Committee on Investments and State Property Management from among experts, specialists from relevant fields or government agencies.
